
AGREEMENT

This Agreement made this 20th day of February 2017 Between, Mr.A.Sivasalopathy, Director, M/s. Eco Coir Cluster India Private Limited, No.12, Ramegounder colony, behind CTC Depot, Coimbatore Road, Pollachi, Pollachi Taluk, Coimbatore District herein after referred to as "**Implementing Agency**" on **ONE PART** and Mr S.Sukumar, Proprietor (Designation), M/s. Sukumar Engineering Exports, having the Registered Office at RSF No:544/1,SillankattuPudur, Arachalur- (P.o),Erode- D.t. hereinafter called the "**SUPPLIER**" on the **OTHER PART**.

2. Whereas the Implementing Agency desired to procure Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System on turnkey basis for **M/s. Eco Coir Cluster India Private Limited, the Special Purpose Vehicle (SPV) of Pollachi Coir Cluster, under Scheme of Fund for Regeneration of Traditional Industries (SFURTI)**, by calling tenders vide Tender Notice No.SFURTI/TN-POL/01/2016-17 dated 29.06.2016, which were opened on 09.08.2016.
3. And whereas the "Supplier" has made an offer for the above said Tender
4. And whereas the "Supplier" has quoted rate of Rs.1,83,09,380/- (Rupees One Crore eighty three lakhs nine thousand three hundred and eighty only) inclusive of all duties & taxes.
5. And whereas the "Supplier" after due negotiation agreed to undertake the assignment at Rs. 15,94,688/- (Rupees Fifteen lakhs ninety four thousand six hundred and eighty eight only) inclusive of all duties & taxes.
6. Whereas the Implementing Agency, based on Tender Committee approval, has accepted the negotiated rate of the "Supplier" vide letter No. ECO/IA/2016/12 dated 24-10-2016.
7. And whereas both "Implementing Agency" and the "Supplier" have agreed to execute an agreement setting out the terms and conditions here under mentioned as agreed to by both the parties to this agreement.
8. **NOW THIS DEED OF AGREEMENT WITNESSES:**
 - (i) **EMD and Security Deposit**
 - a) The "Supplier" has remitted an amount of Rs.20,000/- (Rupees Twenty thousand only) towards Earnest Money Deposit (EMD) in the form of Demand Draft No.049801 dated 28-07-2016 drawn on Karur Vysya Bank.
 - b) The "Supplier" has remitted an amount of Rs. 59,734/- (Rupees Fifty nine thousand seven hundred and thirty four only) towards Security Deposit (SD) being 5% of the value of the contract after adjusting the Earnest Money Deposit of Rs.20,000/-, in the form of Demand Draft No.049855 dated 19.12.2016 drawn on The Karur Vysya Bank Limited, P.Komarapalayam Branch.
 - c) Security Deposit amount will not earn any interest.
 - d) Security Deposit will be retained till the completion of contract.

(ii) Scope of Work and Rates:

- (a) The "Supplier" should undertake supply, erection and commissioning of Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System on turnkey basis at the rate of Rs. 15,94,688/- (Rupees Fifteen lakhs ninety four thousand six hundred and eighty eight only) inclusive of all duties & taxes. The Technical Specifications given in the Annexure-I should be strictly followed.
- (b) The successful tenderer shall demonstrate the performance of the Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System, as stipulated by the Implementing Agency, in complete conformity with the technical specifications and performance parameters specified in Annexure I.
- (c) The performance tests should be completed within 15 days from the date of installation of the machine.

(iii) The detailed price schedule is given as under:

Any upward revision of duties and taxes during the currency of the contract has to be borne by the "Supplier".

9. SCHEDULE OF SUPPLY


- (a) The specification of Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System, should be as per Annexure-I.
- (b) The delivery of Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System, ordered shall be completed within 60 days from the date of issue of purchase order. Delay beyond this period will attract penalty.
- (c) The Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System should be delivered and installed at Survey No.253/B2, Suleeswaranpatti village, Pollachi Taluk, Coimbatore District.
- (d) If the contract is not completed within the stipulated time or extended time, the Implementing Agency will hold full authority to cancel the tender or take any such action that will be deemed fit to the occasion at the risk and cost of the successful tenderer. Such cancellation will entail forfeiture of EMD and Security Deposit.

(e) In the event of non- performance of the contractual provisions or failure to effect the supply within the stipulated time or during the extended period and if it is found that the Contractor, has not fulfilled the contractual obligation with the Implementing Agency in any manner during the currency of the contract or also found on later date, the Implementing Agency reserves the right to disqualify such supplier to participate in future tenders or black list the firm up to a maximum period of 5 years.

10. PERFORMANCE TEST

- (a) The successful tenderer shall demonstrate the performance of the Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System, in complete conformity with the relevant technical specifications and performance parameters as specified in the Purchase Order.
- (b) This demonstration should be done as stipulated by the Implementing Agency.
- (c) The performance tests should be completed within 15 days from the date of installation of Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System.

11. TRAINING OF STAFF

- (a) The tenderer should provide training to Staffs on the operation and maintenance of Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System, before the commencement of performance test.
- (b) The tenderer should provide 2 hard copies and soft copies of brochures & operation manuals for Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System.

12. PERFORMANCE GUARANTEE

- (a) The Double Head Double Conveyor Type Coir Yarn Spinning Machine with Auto Feeding System and its accessories are to be guaranteed, for a period of twelve months from the date of completion of performance test against manufacturing defect, bad workman ship or poor performance.
- (b) During performance guarantee period of 12 months they should attend any call from the Implementing Agency immediately, in case of any problems, related to operation or malfunctioning of the machine, without any delay for regular functioning of the cluster. The above service should be done at Free of cost.
- (c) Upon the complete fulfillment of this contract by the supplier, to the satisfaction of the Implementing Agency, after completion of one year period,

for the satisfactory performance of the machine, the performance security (bank guarantee) furnished by the tenderer will be returned to him, after recovery of dues if any.

13. PAYMENT CONDITIONS

a) **20% of contract value** will be paid on execution of agreement. The Tenderer should produce Bank guarantee for the equal amount, which should be valid for a minimum period of 12 months. If necessary the bank guarantee should be extended for the required period as requested by the Implementing Agency.

b) **75% of the contract value** will be paid on receipt of the complete set of machinery as per the order in full in good condition, at the destination, after acceptance by the tender committee.

c) **The balance 5% and SD** will be paid only after satisfactory completion of the entire contract, including performance test and submission of bank guarantee equivalent to 10% of the total value of contract valid for 1 year towards performance guarantee.

d) The Implementing Agency also reserves the right to recover any dues from the tenderer, which is found on later date, during audit/excess payment, after final settlement is made to them. The successful tenderer is liable to pay such dues to the Implementing Agency immediately on demand, without raising any dispute/protest.

14. PENALTY

a) Failure to execute the entire contract within 60 days from the date of issue of purchase order will attract a penalty of 1% per week, on the full value of the contract upto a maximum of 5%. Delays beyond that period will result in cancellation of the orders.


b) Failure to attend the service complaint reported by the Implementing Agency within 24 hours will attract a penalty of Rs.1,000/- per day.

c) Any delay on the part of the Implementing Agency should be intimated and sorted out immediately without affecting the progress of works. This would no way restrict the Implementing Agency from levying penalty.

15. TERMINATION OF THE CONTRACT

The Implementing Agency reserves the right to terminate the contract at any time during the validity period, on account of non-fulfilment of contract, on any count.

16. GENERAL CONDITIONS

- a) Any other minor items of equipment which is not specifically indicated in the approved specification shall also form part of the "Supplier" scope of supply and should be executed as decided by the Implementing agency without any additional payment if such item is essential for making the project operational..
- b) Any notice regarding any problems, to the supplier shall deemed to be sufficiently served, if given in writing at his usual or last known place of business.
- c) While carrying out the work Supplier is solely responsible for any untoward occurrences to the labours engaged by the "Supplier" and any payment of compensation etc., to such labours..
- d) The "Supplier" should abide by all Government Orders issued from time to time in respect of labour regulations.
- e) The Implementing Agency reserves the right to relax or waive, amend any of these terms & conditions.
- f) In the course of discussion and instruction, the Implementing agency may disclose information of confidential and proprietary nature relating to its products, knowhow, to the "Supplier". Such information shall be considered as confidential.
- g) Any takeover/ change of management during the currency of contract should be intimated to the Implementing agency prior to 15 days of such takeover/change of management.


17. ASSIGNMENT

The "Supplier" shall not directly or indirectly transfer, assign or sublet the contract or any part, share or interest therein nor shall take a new partner without written consent of the Implementing Agency provided nevertheless any such consent shall not relieve the "Supplier" from any obligation, duty or responsibility under the contract.

18. ARBITRATION

a) In case of any dispute in the tender, including interpretation, if any, on the clauses of the tender or the agreement to be executed, the matter shall be referred by the Implementing Agency / Tenderer to an Arbitrator to be appointed by the Parties hereto by mutual agreement. If no such Arbitrator could be appointed by mutual consent, the matter may then be referred to the Chairman, Coir Board for nominating an Arbitrator, the Arbitration proceedings being governed by the Arbitration and Conciliation (Amendment) Act 2015.

b) The venue of the Arbitration shall be at the Regional Office, Coir Board, Pollachi. The decision of the Arbitrator shall be final and binding on both the parties to the Arbitration

c) The Arbitrator may with the mutual consent of the parties, extend the time for making the award. The award to be passed by the Arbitrator is enforceable in the court at Coimbatore only.

19. JURISDICTION OF THE COURT

Any dispute arising out of non-fulfillment of any of the terms and conditions of this Tender/Agreement will be subject to the jurisdiction of the Courts in the City of Coimbatore only.


